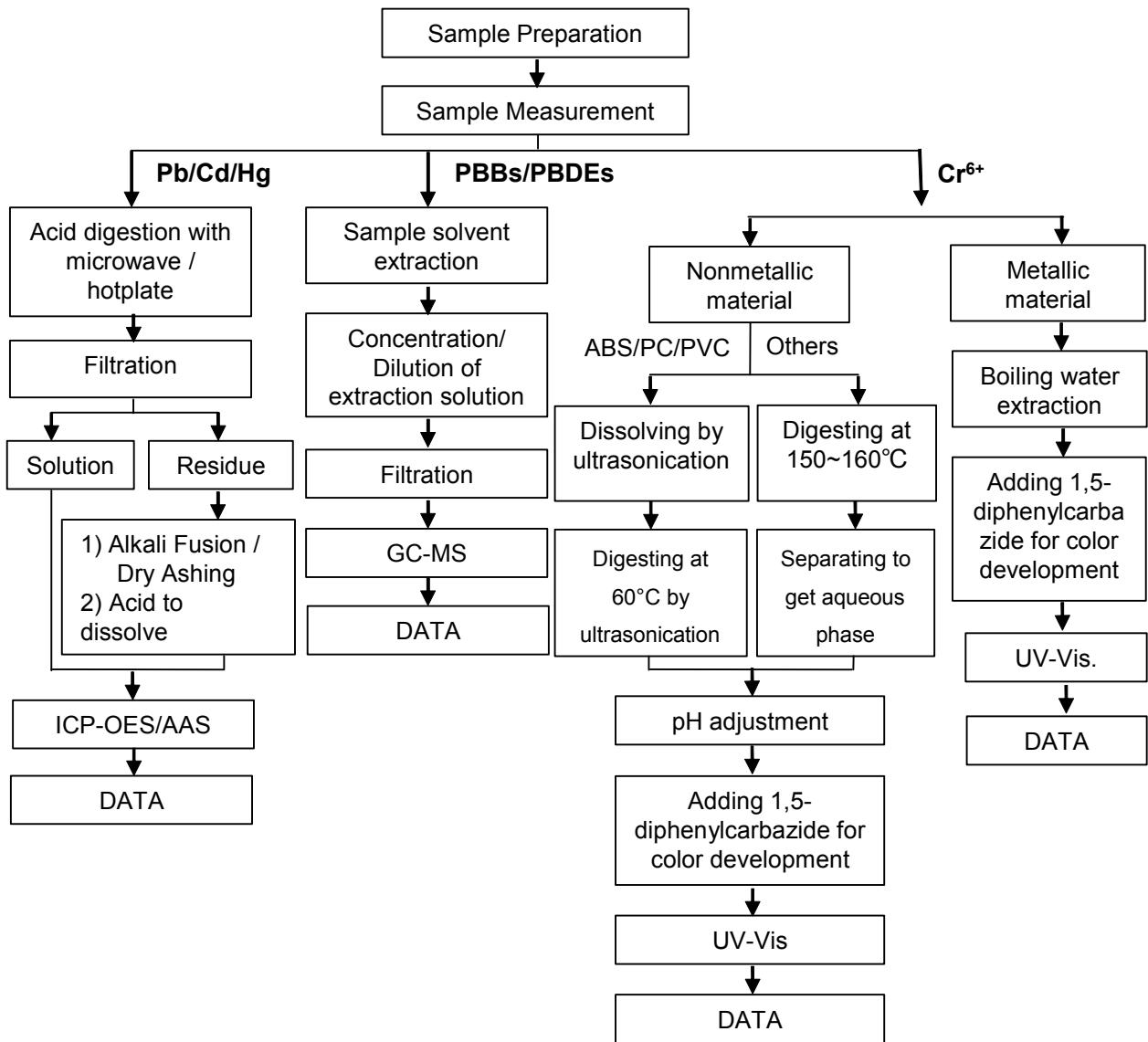

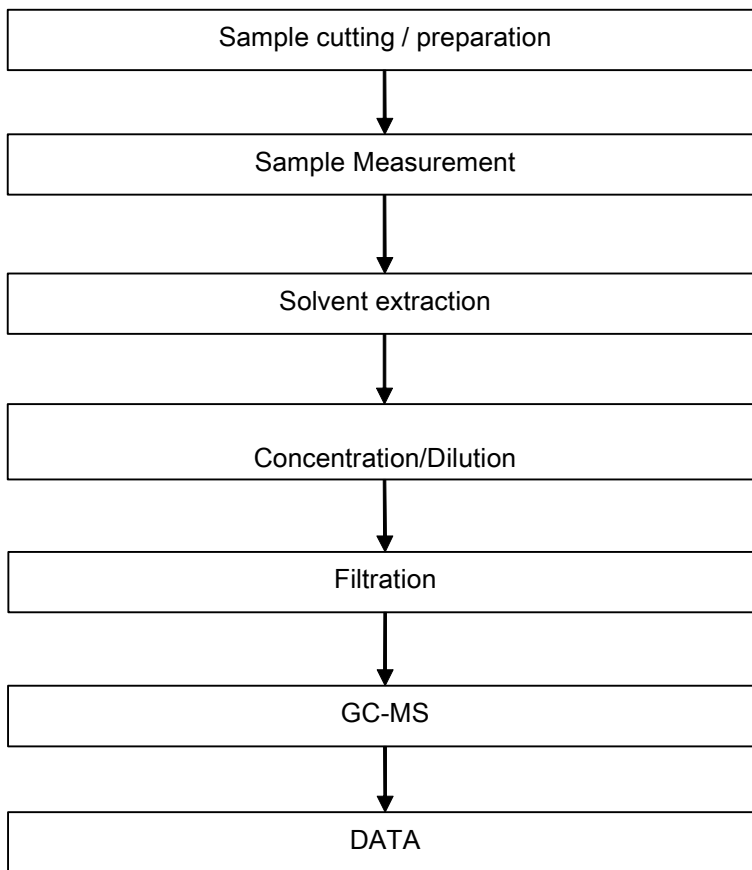
**Pb/Cd/Hg/Cr<sup>6+</sup>/PBBs/PBDEs Testing Flow Chart**

Phthalates Testing Flow Chart

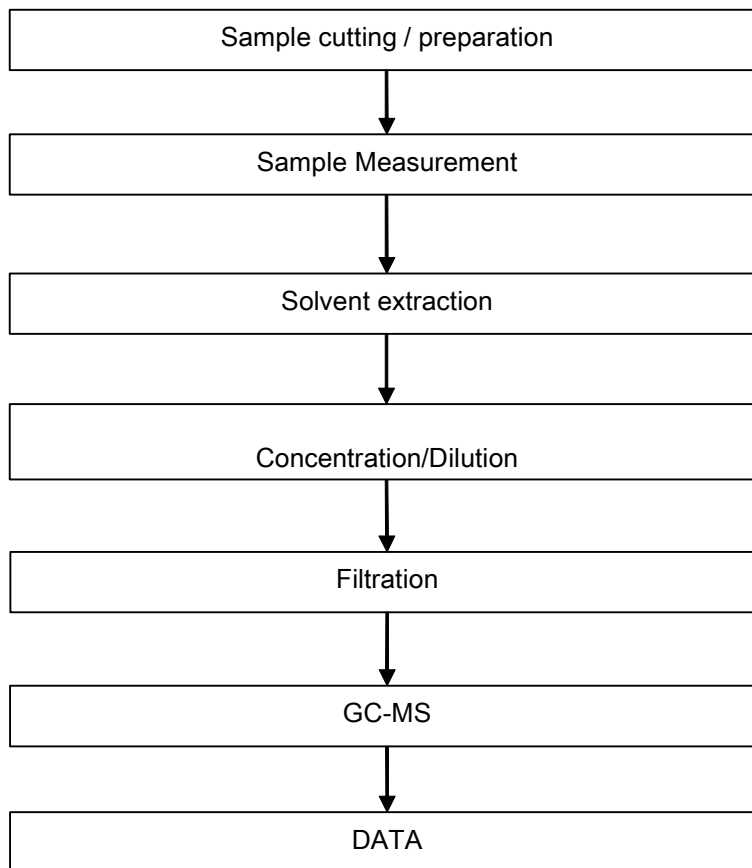

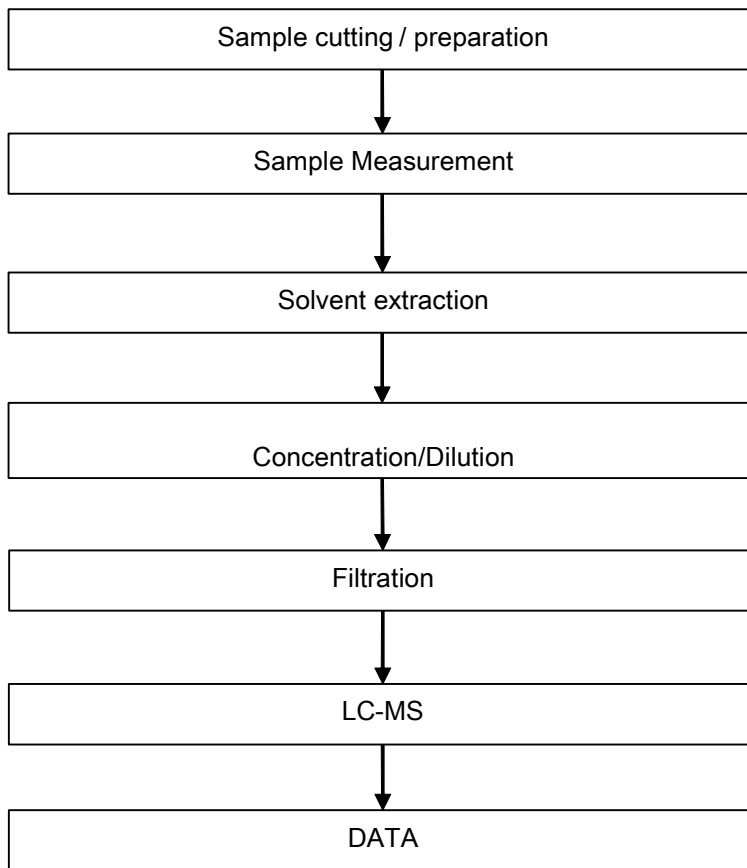
### HBCDD Testing Flow Chart





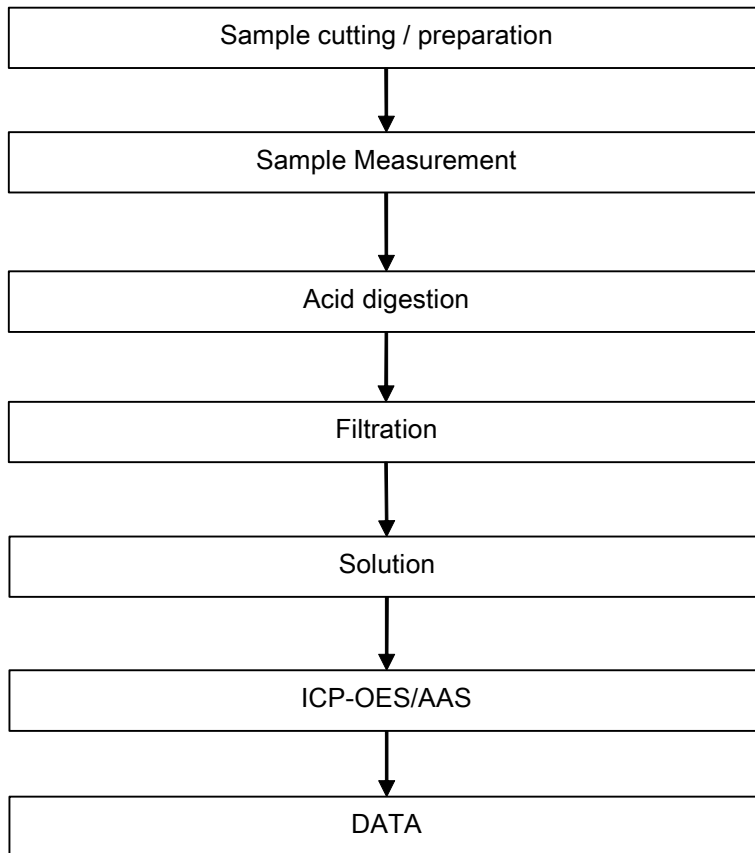

PFOA / PFOS Testing Flow Chart

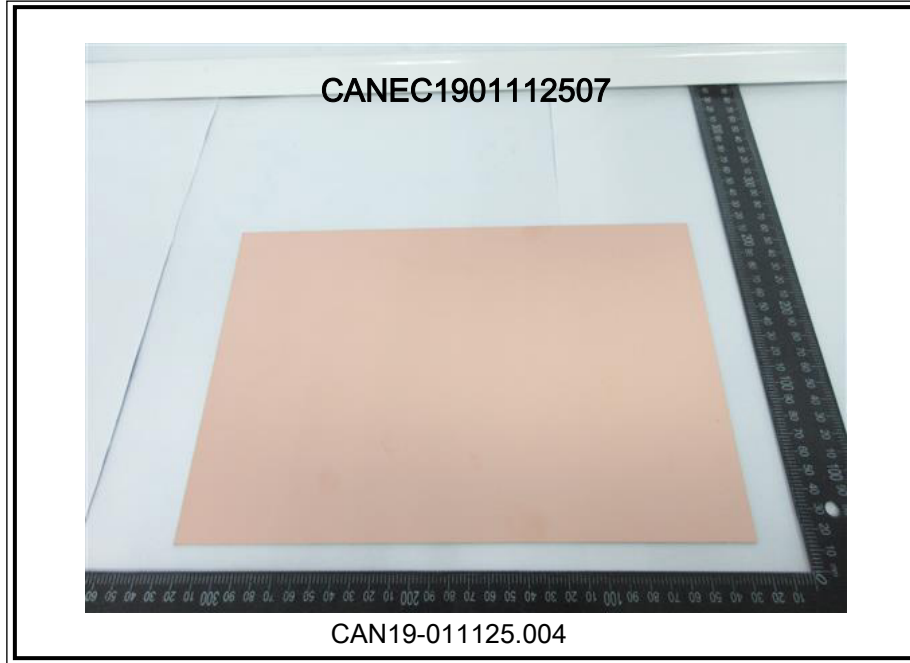
