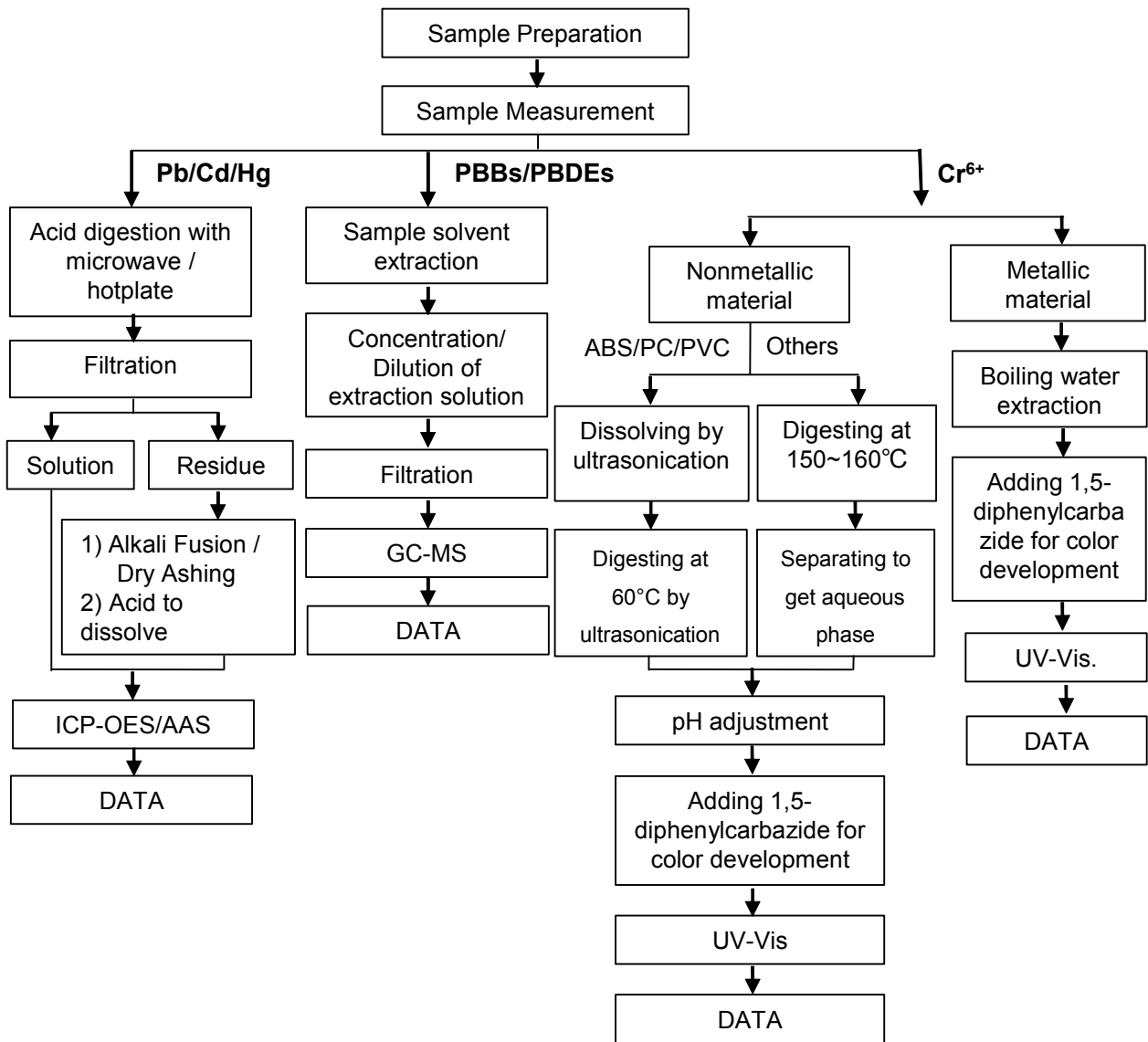

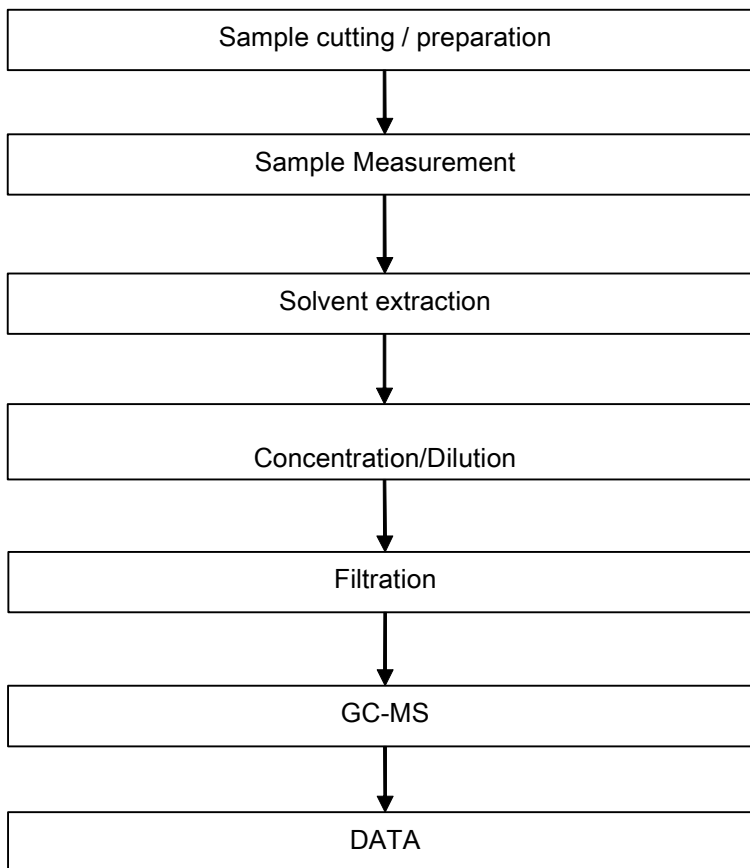
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs Testing Flow Chart

1) These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr⁶⁺ and PBBs/PBDEs test method excluded).



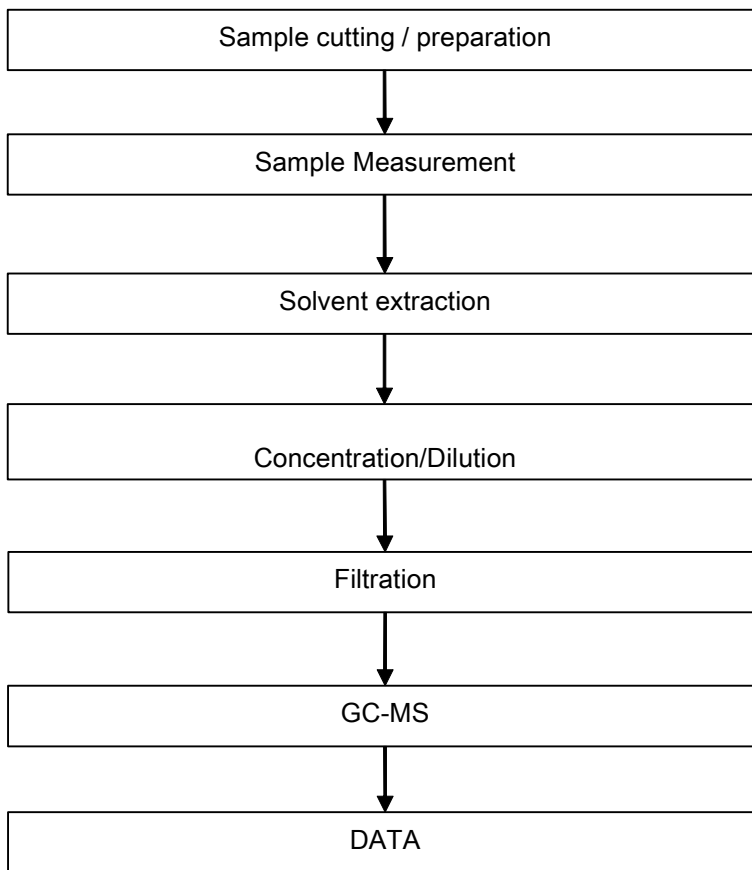

Phthalates Testing Flow Chart



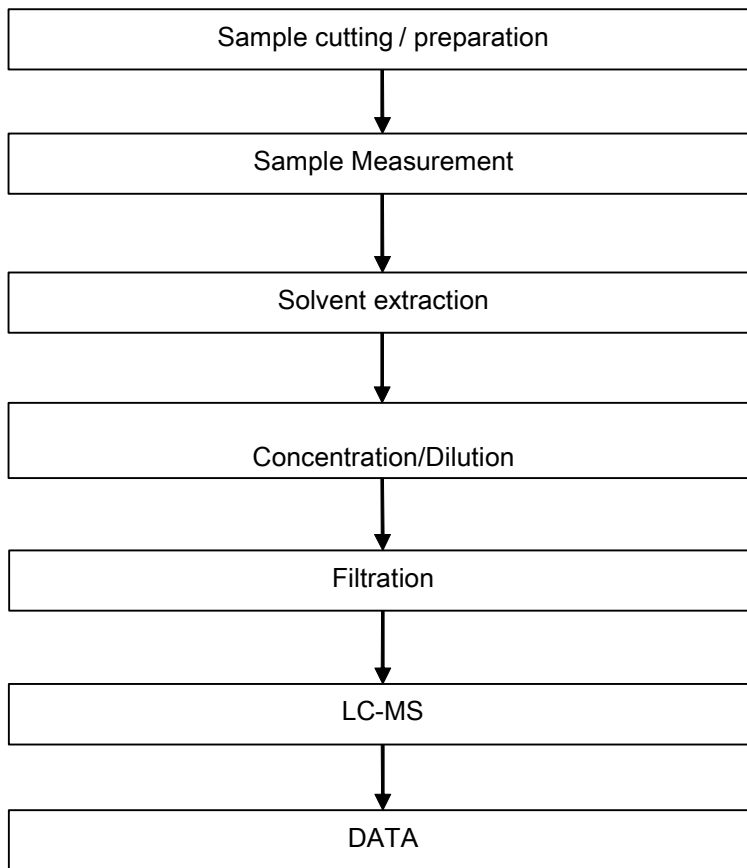

HBCDD Testing Flow Chart



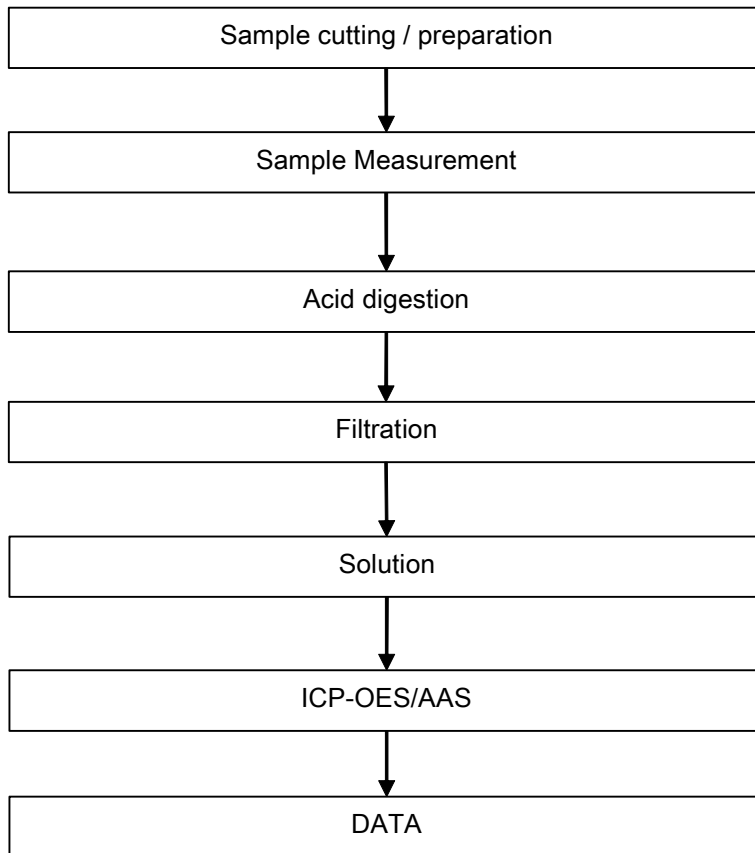
